#### 2021 Telemachus Jewellery Ladies Day Race

#### INVITATION

Southport Yacht Club extends a warm invitation to all owners, skippers and crews of all eligible boats to enter and compete in the 30th Annual Telemachus Jewellery Ladies Day Race to be sailed on the Gold Coast Broadwater on Saturday 10<sup>th</sup> April 2021

#### **ORGANISING AUTHORITY**

The Organising Authority will be Southport Yacht Club Inc. (SYC) located at Macarthur Parade, Main Beach, QLD 4217, Phone (+61) (07) 5591 3500 or Fax (+61) (07) 5532 7507. The race will be conducted from the Hollywell Sailing Squadron located at 1 Marina Crescent, Hollywell, QLD 4216, Phone (+61) (07) 5537 7030 or Fax (+61) (07) 5537 7131.

#### 1. RULES

- 1.1 The series will be governed by the current rules as defined in the Racing Rules of Sailing 2021-2024 (RRS)
- 1.2 The Prescriptions and Special Regulations of Australian Sailing (AS)
- 1.3 The relevant Class Rules (as applicable)
- 1.4 All boats shall always be helmed by a female member of the crew while racing. If any male member of the crew takes the helm of a boat at any time while racing, she shall retire or be scored DNF without a hearing. This changes RRS rule 63.1.
- 1.5 When conflict occurs between the Notice of Race and the Sailing Instructions, the rules of the Sailing Instructions shall prevail. This changes RRS 63.7.
- 1.6 RRS Appendix T Arbitration applies.
- 1.7 All competitors are reminded of RRS 1.1 Helping Those in Danger; A boat or competitor shall give all possible help to any person or vessel in danger.
- 1.8 Current Covid-19 Safe Plan in Place. We are compliant in accordance with the 'Aquatic Sport Sector Industry COVID Safe plan", for Yachting QLD (Sailing) small off the beach craft & yachts. At all times, the Plan is subject to all regulations, guidelines, and directions of Government and Public Health Authorities. Protocols as set out by the Organising Authority, include online pre-registration for the event. Skipper and Crew details will be required to complete the entry. <u>No late entries will be accepted</u>. Cross referencing of all registered Persons on Board (POB's) will be completed between Administration and Race Control with penalties being contained within the Sailing Instructions for non-compliance in affect.
- 1.9 RRS 50.2 and 50.3: Fixed and retractable spinnaker poles and bowsprits will be permitted for the purpose of setting asymmetrical spinnakers.
- 1.10 Rule 49.1 shall not apply to Sports Boats if racing in compliance with their respective class rules and it is noted on the Sports Boats SMS certificate that the boat incorporates hiking devices.

#### 2. SAILING INSTRUCTIONS

The Sailing Instructions will be available from 5pm Sunday 4<sup>th</sup> April 2021 either online or at the Hollywell Sailing Office.

#### 3. NOTICE TO COMPETITORS

- 3.1 Notices to Competitors will be posted on the Official Notice Board located at Southport Yacht Club Sailing Squadron, Hollywell, adjacent to the Southport Yacht Club Sailing Office. Notices may also be posted on the Official on-line Noticeboard on the event website <a href="https://www.southportyachtclub.com.au/sailing-office-notice-board/">https://www.southportyachtclub.com.au/sailing-office-notice-board/</a>
- 3.2 Any change to the Sailing Instructions will be posted before 0900 on the day it will take effect, except that any change to the Schedule of Race will be posted by 1700 on the day before it will take effect.

#### 4. ELIGIBILITY AND ENTRY

- 4.1 All boats shall have a minimum length overall of 16 feet. The Regatta is open to Performance Handicap System (PHS) Rated Racing & Cruising monohull and multihull boats that comply with Australian Sailing Special Regulations Part 1 Category 7.
- 4.2 The person-in-charge of a boat shall be a current financial member of a Club affiliated with Australian Sailing, and an affiliated member of Australian Sailing, and the boat shall be listed on the register of vessels of a Club affiliated with Australian Sailing.
- 4.3 There will be provisions for one Monohull and one Multihull division, with a minimum of Five (5) entries required to constitute a division. Subdivisions may be made at the absolute discretion of the Race Committee and subject to the number of entries received.
- 4.4 A boat shall not change specifications after the close of entries. Any change to the hull, spars, sails, foils, appendages, ballast, equipment, or any other factor which may affect the performance of the boat may be made only with the express written consent of the Race Committee. Substitution of damaged or lost equipment will not be allowed unless approved by the Race Committee. Requests for substitution shall be made to the Committee at the first reasonable opportunity.
- 4.5 Eligible boats shall enter via <u>https://www.topyacht.com.au/db/kb/1265</u> accompanied by the required Entry Fee.

#### 5. FEES

- 5.1 The required entry fee paid up to Friday 2<sup>nd</sup> April 2021 will be \$30.00.
- 5.2 The required entry fee paid from the 3<sup>rd</sup> April 2021 will be \$50.00.
- 5.3 Entries close at 4pm on Wednesday 7<sup>th</sup> April 2021. **No late entries will be accepted.**
- 5.4 Block SYC Special Event entrants are automatically entered in the race.

#### 6. ADVERTISING

- 6.1 Advertising on a boat shall comply with the requirements of ISAF Regulation 20 (ISAF Advertising Code) for Category C.
- 6.2 The Organising Authority may reject an entry of a boat, which in its opinion is carrying advertising conflicting with that of the Regatta sponsors. In any case of doubt, the Organising Authority should be consulted as soon as practicable.

#### 8. VENUE

The Ladies Race Day will be conducted from Southport Yacht Club Hollywell 1 Marina Crescent Hollywell. The racing area shall be the Broadwater, between the Gold Coast Seaway and the entrance to the Coomera River.

#### 9. COURSE

The course to be sailed shall be a Passage Race as described at the compulsory Skippers briefing.

#### **10. HANDICAPPING**

Results will be based on a Performance Handicap System (PHS) Time Correction Factor (TCF). The TCF will be allocated by the Race Committee or its nominee, will be performance-based, will be expressed as three (3) decimal places applied as a multiplier to elapsed times, and will not be subject to protest, redress or dispute.

#### **11. PENALTY SYSTEM**

- 11.1 Rule 44.1 is changed so that the Two-Turns Penalty is replaced by a One-Turn Penalty, including one tack and one gybe in the same direction.
- 11.2 Failure to comply with the Covid 19 requirements regarding pre-registration information shall result in a vessel scoring a ENP (Event Nominated Penalty) as per RRS 44.3(c)
- 11.3 Infringement of NOR 1.4 will result in a boat being scored DNF without a hearing.

#### 12. SCORING

The Low Point Scoring System, Appendix A2 will apply.

#### 13. RIGHTS TO USE NAME AND LIKENESS

By participation in the Ladies Day Race, a competitor automatically grants to the Organising Authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for said event in which the competitor participated and in all material related to the said event without compensation.

#### 14. RISK STATEMENT

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.** 

#### **15. INSURANCE**

Each participating yacht shall be insured with valid third-party liability insurance with a minimum cover of \$10, 000, 000.00 per incident or the equivalent, which also includes coverage for racing in the regatta. Proof of Insurance may be required, clearly indicating the person, the amount and the period of coverage, at registration. All owners/competitors who complete an Entry are deemed to have made this declaration that they hold such coverage.

#### 16. PRIZES

- 16.1 Prizes will be awarded to First, Second, Third on Handicap;
- 16.2 A prize will be awarded to the boat with the Fastest Elapsed Time;
- 16.3 A prize will be awarded to "The Best Dressed Boat".
- 16.4 Other Prizes may be awarded at the discretion of the Race Committee.
- 16.5 The Overall First Place Winner of the 2021 Telemachus Jewellery Ladies Day Race will be presented with the Telemachus Jewellery Ladies Day Race Perpetual Trophy at the Annual Sailing Presentation Night, held at Southport Yacht Club Main Beach.
- 16.6 The Skipper or a crew member of the yacht must be present at the presentation to receive prizes. Prizes not collected during the presentation will be redrawn to the next placings accordingly.
