INVITATION

Southport Yacht Club and the Southport Yacht Club Hollywell Sailing Squadron invite all owners, skippers and crews of all eligible Off-The-Beach Multihull yachts to enter and compete in the 2022 CAT Weekend.

ORGANISING AUTHORITY

The Organising Authority shall be Southport Yacht Club Inc. (SYC) located at 1 Marina Crescent, Hollywell.

1 RULES

- 1.1 The 2022 CAT Weekend Regatta is governed by the current Rules as defined in *The Racing Rules of Sailing* (RRS).
- 1.2 The Special Regulations of Australian Sailing: Part 2 shall apply for Off-The-Beach Catamarans participating in the Regatta.
- 1.3 Where there is conflict between rules, other than RRS, the Sailing Instructions shall prevail. This changes RRS 63.7.
- 1.4 Appendix T Arbitration will apply.
- 1.5 All competitors are reminded of RRS 1.1 Helping Those in Danger, whereby "A boat or competitor shall give all possible help to any person or vessel in danger".
- 1.6 Compliance with Qld Government COVID-19 contact tracing via the electronic app "Check in Qld".

2 SAILING INSTRUCTIONS

3 NOTICES TO COMPETITORS & REGATTA SITE

The Regatta office will be located at Southport Yacht Club, Hollywell. The Official Notice Board is on the Southern Wall, adjacent to the Southport Yacht Club Sailing Office, 1 Marina Crescent, Hollywell, Qld 4216. Additionally, notices may be posted to the Official Online Notice Board <https://www.southportyachtclub.com.au/sailing-office-notice-board/>.

4 ELIGIBILITY AND ENTRY

- 4.1 The Regatta and included races are open to all classes of Off-The-Beach Multihull, who comply with Australian Sailing Special Regulations Part 2 for Off-The-Beach Boats.
- 4.2 Every yacht shall be entered by and shall have on board while racing a person-in-charge who shall be a current financial member of a Club affiliated to Australian Sailing and an Australian Sailing card holder (SIN), or, if an international competitor, a member of a club affiliated to a World Sailing recognised Member Notional Authority, in accordance with the Australian Sailing prescription to Rule 46.
- 4.3 Where the person-in-charge of a yacht is under the age of eighteen (18) years of age, their Parent or Guardian shall complete a Parent Declaration Form which is available by contacting the Hollywell Sailing Office.
- 4.4 Entries shall be lodged via <https://www.southportyachtclub.com.au/sailing/special-sailing-events-2/> before entries close, as per the Schedule of Events.
- 4.5 Entries close midnight Friday 11th February 2022.
- 4.6 Divisions are defined as follows:

Division	Yardstick
1	< 78
2	> 78

Additional sub-divisions may be allocated by the organising authority.

5 ENTRY FEE

- 5.1 The Early Bird Entry fee, paid on and before Saturday 5th February 2022 is \$55.00 for all Divisions;
- 5.2 All Entries paid from Sunday 6th February 2022 are \$65.00 for all Divisions.
- 5.3 Eligible boats shall enter via the Southport Yacht Club website located at <http://www.southportyachtclub.com.au/sailing/special-sailing-events-2/> accompanied by the required Entry Fee.
- 5.4 Entry includes a competitors Sausage Sizzle after racing on Sunday 13th February 2022

6 RACING AREA

The racing area will be the Gold Coast Broadwater, between Wave Break Island and the Never Fail Islands.

8 VENUE

The 2022 CAT Weekend will be conducted from Southport Yacht Club Sailing Squadron, 1 Marina Crescent Hollywell Qld 4216.

9 THE COURSES

- 9.1 The Courses for this Regatta will be a combination of Windward/Leeward courses and Passage type courses as described at the daily compulsory briefings and/or as outlined in the Sailing Instructions.
- 9.2 Up to six (6) races will be scheduled for this Regatta.

10 PENALTY SYSTEM

- 10.1 Alternative Penalties - The two-turn penalty (RRS 44.1) is changed to a one-turn penalty.
- 10.2 Event Nominated Penalties – Breaches of Sailing Instruction Safety requirements and Covid registrations shall be a 20% scoring penalty. This will not be grounds for a protest by a boat. This changes RRS 60.1(a). The scoring abbreviation for a Event Nominated Penalty imposed under this instruction will be (ENP).
- 10.3 The penalty shall be applied to the race sailed nearest, in time to that of the breach.

11 SCORING

- 11.1 Two races must be completed to constitute a series.
- 11.2 A yacht's Series Score will be the total of her race scores.

12 SUPPORT PERSON VESSELS

Registration of Support persons vessels shall be made at the sailing office prior to entering the race area.

13 RIGHTS TO USE NAME AND LIKENESS

By entering and participating in this event, a competitor automatically grants to the Organising Authority, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her and their vessel, during the period of and after the competition of said event in which the competitor participated, and in all material, related to the said event without compensation.

14 DISCLAIMER OF LIABILITY

All persons taking part in this regatta, whether as an entrant or otherwise, do so at their own risk and responsibility. The Organising Authority are not responsible for the seaworthiness of a yacht whose entry is accepted or the sufficiency or adequacy of its equipment. The Organising Authority reserved the right to refuse or withdraw an entry at any time. Attention is drawn to RRS Fundamental Rule 3 which states: "*The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.*". The Organising Authority will not accept any liability for material damage, personal injury or death sustained in conjunction with, prior to, during or after this Regatta.

15 INSURANCE

Each participating yacht shall be insured with valid third party liability insurance, with a minimum cover of \$10M (AUD) for any one incident. By taking part in a race all yacht owners are deemed to have made a declaration that they have such cover.

16 PRIZES

- 16.1 Prizes will be awarded to First, Second and Third places in each division.
- 16.2 Perpetual Trophies will be awarded to the overall winners in each division
- 16.3 Other prizes may be awarded at the discretion of the Organising Authority.
