1. RULES

- 1.1 The race will be governed by the rules, as defined in The Racing Rules of Sailing 2021-2024 ("RRS") of World Sailing, including;
 - a. the IRC Rules 2021 Parts A, B and C;
 - b. the ORC Rating Rules 2021;
 - c. the Prescriptions and Special Regulations of Australian Sailing ("AS Special Regulations")
 - d. applicable Special Regulations for Category 3 events as amended and including N.
- 1.2 A compulsory skippers briefing & registration will be held at SYC Main Beach on Thursday 12th January at 1900hrs.
- 1.3 When conflict occurs between the Notice Of Race and the Sailing Instruction's, the rules of the Sailing Instruction's shall prevail. This changes RRS 63.7.
- 1.4 All yachts shall carry (as a minimum), a Personal Life Beacon (PLB) for each crew member and provide the OA with a detailed crew list and their allocated PLB Hex identification #. If any yachts use GPS capable 406 MHZ PLB's, then they are to provide the OA with a detailed crew list and their allocated PLB MMSI #'s.
- 1.5 Changes to RRS in accordance with SI's 13, 17, 19 and 23.

2. CHANGES TO SAILING INSTRUCTIONS

2.1 Any changes to the Sailing Instructions made ashore will be posted at least one (1) hour before the race affected and the Notice to Competitors will be signalled by the display of Code Flag "L" ashore.

3. NOTICES TO COMPETITORS

- 3.1 Notices to competitors will be posted on the Official Noticeboard at Southport Yacht Club Sailing Squadron. Notices may also be posted on the Southport Yacht Club online noticeboard <u>https://www.southportyachtclub.com.au/sailing-office-notice-board/</u>
- 3.2 The race office is located at 1 Marina Crescent, Hollywell, (07) 5537 7030, sailing.reception@sycgc.com.au.
- 3.3 On the water, the race committee intends to monitor and communicate with competitors on VHF radio channel 09.
- 3.4 Except in an emergency, a yacht shall neither make radio transmissions while racing, nor receive radio communications not available to all boats.
- 3.5 Race results for this event will be posted on the Regatta Noticeboard/s as soon as practicable after the event, as well as being posted online <u>https://www.southportyachtclub.com.au/sailing/special-sailing-events-2/</u>.

4. CODE OF CONDUCT

- 4.1 Competitors and support persons shall comply with reasonable requests from race officials.
- 4.2 Competitors and support persons shall handle any equipment or place advertising provided by the organizing authority with care, seamanship, in accordance with any instructions for its use and without interfering with its functionality.

5. SIGNALS MADE ASHORE

5.1 Signals made ashore will be displayed from the flagpole located on the Quarterdeck of Southport Yacht Club, Main Beach.

6. SCHEDULE OF EVENTS

6.1 The following is the schedule of events (Australian Eastern Standard Time – Qld):

7. DIVISIONS

7.1 The Race will comprise of one (1) division.

8. CLASS FLAGS

8.1 The Class Flag for the Warning Signal for all yachts shall be International Code Flag 'T'.

9. RACING AREA

9.1 The Racing Area will be the offshore waters between the Gold Coast Seaway and Julian Rocks located in the vicinity of Byron Bay.

10. THE COURSE

The course will be a coastal passage race, as follows:

- 10.1 Start in the vicinity of the Gold Coast Seaway Sand Bypass Jetty, between the Starting Mark (Port) and the Race Committee Vessel (Starboard).
- 10.2 Proceed in a Southerly direction towards Byron Bay, leaving Cook Island to Starboard.
- 10.3 Round Julian Rocks (approximately 028°36.9'S 153°38.3'E) to Starboard
- 10.4 <u>All Yachts must at all times NOT be within 200m of the Julian Rocks trigonometric station, situated on</u> <u>Julian Rocks</u>.
- 10.5 Proceed in a Northerly direction towards the Gold Coast, leaving Cook Island to Port.
- 10.6 Proceed to the Finish Line in accordance with SI 16.
- 10.7 The Course will be as shown in Illustration A, attached.

11. MARKS

- 11.1 The Starting Mark will be an Orange with black top and bottom inflatable cylinder, approximately 1.50 Metres high x 0.60 Metres diameter.
- 11.2 Julian Rocks (approximately 028°36.9'S 153°38.3'E) located in the vicinity of Byron Bay forms the turning point and shall be rounded to starboard.

12. AREAS THAT ARE OBSTRUCTIONS & PROHIBITED AREAS.

The following areas are designated as obstructions:

- 12.1 Julian Rocks, All Yachts must at all times not be within 200m of the Julian Rocks trigonometric station, situated on Julian Rocks.
- 12.2 All coastline "Shark Nets" are to be passed to seaward and are designated obstructions.
- 12.3 For the purposes of RRS 19 & 20, "Wonder Reef" the Gold Coast dive attraction which is located 2.5 km east of Main Beach at approximately 27° 57.70' S, 153° 27.30' E is a continuing obstruction and a prohibited area. This area is defined with four (4) yellow special marker buoys. Should any of the four (4) yellow special marker buoys be missing, a boat is still not permitted into the prohibited area. A boat shall not sail into a prohibited area.

13. THE START

- 13.1 The Race will be started according to RRS Rule 26.
- 13.2 The Starting Line shall be between a staff displaying an Orange flag or shape on the Race Committee Vessel at the Starboard end of the line, and the Starting Mark at the Port end, located approximately 1 nautical mile to the East of the seaward end of the Sand Bypass Jetty, at approx. 27°56.4'S, 153°27.0'E.
- 13.3 A yacht starting later than twenty (20) minutes after her Starting Signal will be scored Did Not Start without hearing.
- 13.4 Individual Recalls will be signalled according to RRS 29.1, except that in the event of an Individual Recall the Race Committee Vessel will attempt to contact the recalled yacht on VHF09 as soon as possible but no later than fifteen (15) minutes after the Starting Signal. This modifies RRS 29.1.
- 13.5 General Recalls will be signalled according to RRS 29.2
- 13.6 All yachts must comply with SI 21.2 in order to Start.

14. CHANGE OF COURSES AFTER THE START

14.1 There is no provision for a change of course after the start.

15. SHORTENED COURSE

15.1 The Course will not be shortened by the Race Committee.

16. THE FINISH

- 16.1 The Finishing Line shall be the imaginary line formed between the Sand Bypass Jetty, located to the South of the Gold Coast Seaway and GPS Co-Ordinates 27° 56.315'S / 153° 26.500'E. Yachts shall cross the finishing line in a northerly direction.
- 16.2 Yachts shall record their own finishing time and text Simon Turpin on 0400 558 917 <u>within 20 minutes</u> of their finishing time, providing **Yacht Name**, Finishing Time (**HRS:MIN:SEC**), & confirming **POB** (#).
- 16.3 All Skippers shall complete and submit a Skippers Declaration Form (attached to these Sailing Instructions as Appendix A) as soon as possible after finishing but no later than 1600 hours on Sunday 15th January 2023. Skipper Declarations shall be submitted via mms text to Simon Turpin on 0400 558 917 or via email to sailing.ops@sycgc.com.au.

17. PENALTY SYSTEM

- 17.1 Between the hours of sunrise and sunset, the two-turn penalty (RRS 44.1) is changed to a one-turn penalty for infringement of the rules of Part 2 of the RRS.
- 17.2 Between the hours of sunset and sunrise, Rule 44.3a is amended so that a boat need not display a yellow flag, however a boat that takes a scoring penalty shall submit a declaration (attached to the Sailing Instructions) to the race committee as soon as practical but no later than 1600hrs on Sunday 15th January, 2023.
- 17.3 Rule 44.3c is amended so that a boats scoring penalty for a breach of RRS Part 2, will be ten (10) minutes added to their actual finish time.
- 17.4 Yachts failing to comply with SI 16.2, SI 16.3, SI 21.3, SI 23, will have a fifteen (15) minute scoring penalty added to their actual finish time for <u>each</u> infringement without hearing.

18. TIME LIMIT

18.1 The time limit for the race will be thirty (30) hours from the time of the starting signal. Yachts which have not finished by this time will be scored DNF without hearing.

19. PROTESTS & HEARING REDRESS

- 19.1 Protests shall be submitted on the Hearing Request Form, available from the SYC Sailing Office at the Hollywell Sailing Squadron or Reception Desk at Main Beach and delivered there ASAP, but no later than 1600 hours on Sunday 15th January, 2023.
- 19.2 Hearing Notices will be posted within two hours (120) minutes of the Protest Time Limit to inform competitors when and where there is a hearing in which they are parties to a hearing or named as witnesses.
- 19.3 Hearings will be heard in approximately the order of receipt and as soon as possible.
- 19.4 Yachts, which divert from their optimum course for the purposes of search and/or rescue, or alternatively when carrying out their obligations under ISAF RRS 1.1, are strongly advised to keep a detailed log of their movements and are invited to make an application to the Race Committee for redress. The granting of and the extent and method of calculating redress shall be at the absolute discretion of the Race Committee, except that the outcome of a successful application for redress shall not result in the abandonment of the race. This amends ISAF RRS 64.2.

20. SCORING

20.1 The Low Point Scoring System, Appendix A. will apply.

21. SAFETY REGULATIONS

- 21.1 When departing or entering the Gold Coast Seaway, the Organising Authority strongly encourages all skippers to carefully observe the prevailing conditions and wave patterns. Skippers are strongly encouraged to have all crew on deck, all hatches securely closed and to consider the need for personal flotation devices whilst crossing the Seaway.
- 21.2 All Yachts shall report to the Race Committee vessel at the starting area for a visual inspection Sign On. All crew are required to be on deck, each wearing their compliant safety harness and tether in hand for visual inspection (compliant in accordance with AS Special Regulation 5.02 SAFETY HARNESS AND SAFETY LINES (Tethers)). Upon visual inspection by the Race Officer, confirmation of Persons on Board (POB) will be hailed by the Race Officer to the Skipper of each Yacht confirming these details.
- 21.3 All yachts shall observe the mandatory Position Reporting Schedules (PRS). Failure of a yacht to report for two (2) consecutive PRS will automatically initiate Search and Rescue (SAR) actions. In the event that an unnecessary SAR is launched, any associated costs may be incurred by the yacht owner or their representative.
- 21.4 Yachts which retire from the race shall inform 'SYC RACE CONTROL' as soon as possible and are to maintain observance of the SMS Position Reporting Schedules until they enter the Gold Coast Seaway and log-off with Volunteer Marine Rescue Seaway Tower (Call sign "V.M.R. 414 SEAWAY TOWER", VHF73 or Channel 27.91MHz).

22. COMMUNICATIONS

22.1 The deliberate transmission of untrue position reports by a yacht will incur penalties to be applied at the discretion of the race committee or protest committee including disqualification of the yacht.

23. RADIO INSTRUCTIONS & SMS POSITION REPORTING SCHEDULES

23.1 VHF RADIO STATIONS

The Race Control Centre of Southport Yacht Club may maintain a listening watch on, **VHF16** for the duration of the Race. The call sign will be "SYC RACE CONTROL". Alternative phone contact is the Race Officer (RO) mobile #: 0400 558 917 (Simon Turpin – Sailing Operations Manager).

23.2 DEPARTURE LOG-ON AND ARRIVAL LOG-OFF

- (i) All yachts shall log-on with Volunteer Marine Rescue Seaway Tower (Call sign "V.M.R. 414 SEAWAY TOWER", VHF73 or Channel 27.91MHz) prior to departing, stating the Vessel name and Registration Number, number of persons on board, and the estimated time of returning.
- (ii) All yachts shall log-off upon entering the Gold Coast Seaway after finishing or retiring from the race.

NB: Seaway Tower is closed between and including the hours of 1800hrs and 0500hrs. Please refer your communications to "VMR 400 Southport" on Ch 73 during these hours. They will in turn notify Seaway Tower.

23.3 SMS POSITION REPORTING SCHEDULES (PRS)

Yachts will send an sms to the RO mobile #: 0400 55 8917 when they are:

- 1. Marine Rescue Point Danger abeam Marine Rescue Point Danger
- 2. Marine Rescue Cape Byron at Julian Rocks
- 3. Marine Rescue Point Danger abeam Marine Rescue Point Danger on the return trip

Yachts shall report in this sms, stating the following information:

- Vessel Name and Registration Number
- Current **position** as Latitude/Longitude
- General **direction** of travel (i.e.: heading South or heading North)
- Estimated Time of Finishing (ETF)
- Any relevant information regarding the yacht, crew or severe weather.

A return sms will be sent to each for confirmation.

The RO will call yachts which have failed to report and may ask for sightings of any unreported yachts. The RO may, at their discretion, direct yachts to use other frequencies or to relay information if difficulties in communication are experienced.

23.4 RADIO RESTRICTIONS

No restrictions are placed on the receiving of weather information broadcast by Government or commercial stations. This amends RRS 41.

23.5 SEVERE WEATHER FORECASTS

Requests for, the passing of, and receipt of information regarding severe weather warnings shall not be regarded as an infringement of RRS.

23.6 VHF MONITORING CHANNEL

All Yachts shall maintain a listening watch on Channel VHF16 whilst racing.

23.7 TACKTRACKERS

A boat shall carry a tracking device if so required by the OA. The device will be supplied by the OA. The TackTracker link for delayed broadcasting may be viewed at: https://tacktracker.com/cloud/regattas/show/1857644752

24. PRIZES

- 24.1 The Line Honours prize will be awarded to the first boat to finish.
- 24.2 Prizes will be awarded to 1st, 2nd, & 3rd on corrected time for IRC, ORCclub & PHS Results.
- 24.3 The overall first place winner on corrected time of ORC Club results will be presented with the Southport Yacht Club Julian Rocks Perpetual Trophy.
- 24.4 Southport Yacht Club Navigators Perpetual Trophy To be eligible for the Navigators Prize, a vessel's Skipper shall **SMS TEXT** to Simon Turpin **0400 558 917** of their Estimated Time of Finishing immediately upon rounding Julian Rocks. This prize will be awarded to the yacht which has the closest actual finishing time to their estimated time of finishing.
- 24.5 Other Prizes may be awarded at the discretion of the Race Committee.
- 24.6 Announcement of overall results and presentation of prizes will take place at 1700hrs on Sunday 15th January 2023 at the Southport Yacht Club Main Beach Clubhouse.

25. INDEMNITY


- 25.1 Any entrant found to be deliberately invalidating certificates, falsifying documentation or otherwise misleading the Race Committee may be subject to action under ISAF RRS 69.1. If the Protest is upheld the yacht may be subject to disqualification from any future SYC event and the incident will be reported to Australian Sailing.
- 25.2 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.
