(A1, B1, C1) Pegasus tacked to port & sailed towards Sneaky Ninja (A2, B2) Sneaky Ninja hailed starboard and as the two boats came close to a collision point, Sneaky Ninja tacked away to avoid the contact. Pegasus infringed RRS 10 and did not do the penalty turn.
